Dear Sir/ Madam,

To propel Indian Technical Education towards global standards and excel in the employability skills of technical students aligned with the New India Vision of Shri Narendra Modi ji, Hon'ble, Prime Minister of India, various quality initiatives were taken by AICTE in 2017. Revision of curriculum and Mandatory 6 months' internships for industrial exposure to students is one such initiative.

AICTE has mandated six- month internships as a part of Model curriculum for technical institutions. AICTE Internship policy mandates a minimum of 14-20 credits of Internship activities for B. Tech. degree programmes and 10-14 credits for three-year diploma programme. This will result in about 600 to 700 hours of total internship duration for B. Tech and 450-500 hours for Diploma students.

It has been found that many of colleges are facing difficulties in tracing the adequate numbers of internship opportunities especially during the lockdown period. To eradicate this problem, AICTE Internship enterprise portal has been developed and launched.

The portal will bring together the internships opportunities in Government sector like Ministry of Housing and Urban Affairs (MoHUA), National Highway Authority of India (NHAI), Railways, MSMEs, Corporates Sector, NGOs, Start-ups as well as Research organisations. The key features of AICTE Internship platform are enumerated as below:

- Create internship requirement in no time,
- Provides full time / part time / virtual Internships.
- Auto match profile of the student with requirements of employer. viz; skills, graduation date, location, qualification etc.
- Generate offer letter and completion certificate.
- Real-time performance dashboard with end-to-end digitalization of processes.
- Superfast search results which is also mobile and desktop enabled.

The portal was launched by the Honorable Minister of Human Resource Development, Sh. Ramesh Pokhriyal 'Nishank' and Honorable Minister of State (I/C) Housing and Urban Affairs, Shi Hardeep S. Puri on 4th June 2020.

With a view to take this vision of honourable PM, to all relevant organisations, I request that your organisation may also participate in this initiative by providing your requirement of interns at the portal. AICTE Internship Portal has potential to connect with more than 80 lakh students and about 4 lakh faculties enrolled in approximately 10,000 AICTE approved institutions. You are requested to register yourself in appropriate category (PSUs/Corporate/Govt. Department etc.). After registration, you can post requirements for interns.
